The UAE and Israel: Three Years of Progress

The years on, the Abraham Accords are delivering on their promise of expanded trade and commerce, deeper people-to-people ties, and a more integrated region. Collaboration is taking place across numerous fields, including trade, investment, health, technology, agriculture, tourism and more. Below is an overview of joint achievements following the Accords.

Diplomatic

- **HE Obaid bin Humaid Al Tayer**, Minister of State for Financial Affairs, **HE Abdullah bin Touq Al Marri**, Minister of Economy, and **HE Omar Ghobash**, Assistant Minister for Culture and Public Diplomacy at MOFAIC, visited Israel (October 2020).
- **HE Mohamed Al Khaja** presented his credentials to Israel's former President Reuvin Rivlin, becoming the first UAE Ambassador to Israel (March 2021).
- Israel's Foreign Minister and Alternate Prime Minister Yair Lapid made his first official visit to the UAE. The Israeli Embassy in Abu Dhabi and Consulate General in Dubai formally opened (June 2021).
- UAE Embassy in Tel Aviv formally opened (July 2021).
- **HE Mariam Almheiri**, Minister of State for Food and Water Security, visited Israel (July 2021).
- HH Sheikh Abdullah bin Zayed Al Nahyan, Minister of Foreign Affairs and International Cooperation, <u>participated</u> in a virtual call with his counterparts from Israel as well as the US and India to form the I2U2 group. (October 2021).
- HH Sheikh Mohamed bin Zayed Al Nahyan <u>met</u> with Israeli President Isaac Herzog during his first visit to the UAE (January 2022).
- Israel hosted the <u>first Negev Forum</u>, welcoming the top diplomats from the **UAE** and US along with other Arab countries (March 2022).
- HH Sheikh Mohamed bin Zayed Al Nahyan <u>received</u> Israeli Prime Minister Naftali Bennett during his second visit to the UAE (June 2022).
- The UAE, Israel and US <u>launched</u> the inaugural I2U2 Summit, convening leaders from the three countries and India to collaborate on economic and trade matters (July 2022).
- HH Sheikh Abdullah bin Zayed Al Nahyan <u>became</u> the first UAE foreign minister to visit Israel. Sheikh Abdullah met with Israeli President Isaac Herzog and attended a

reception marking the two-year anniversary of the signing of the Abraham Accords (September 2022).

- HH President Sheikh Mohamed bin Zayed Al Nahyan <u>met</u> with President of Israel Isaac Herzog (December 2022).
- Under Secretary of State for Economic Growth, Energy, and the Environment Jose W.
 Fernandez <u>participated</u> in I2U2 initiative's inaugural business forum, hosted in Abu
 Dhabi by UAE Minister of State HE Ahmed bin Ali Al Sayegh (February 2023).
- HH President Sheikh Mohamed bin Zayed Al Nahyan and Prime Minister Benjamin Netanyahu <u>spoke</u> about "their commitment to advancing their historic peace deal" (April 2023).
- HH President Sheikh Mohamed bin Zayed Al Nahyan <u>sent</u> a letter to President Isaac Herzog to officially invite Israel to attend the COP28 climate conference (May 2023).

Economy & Trade

- **DP World** <u>signed</u> a Memorandum of Understanding with Israel's **Bank Leumi** to explore potential financing to develop Israel's port sector (September 2020).
- Emirates NBD <u>signed</u> an MOU with Israel's Bank Hapoalim to allow bank services between the two countries (September 2020).
- **DP World** <u>signed</u> MOUs with Israel's **DoverTower** to explore opportunities to develop infrastructure for trade between Israel and the UAE and the region (September 2020).
- Jebel Ali Free Zone <u>entered</u> into a strategic agreement with the Federation of Israeli Chambers of Commerce to support businesses and encourage economic cooperation (September 2020).
- The Dubai Airport Free Zone Authority <u>signed</u> an MOU with the Federation of Israeli Chambers of Commerce to support Israeli companies in establishing business in Dubai (September 2020).
- **Dubai Chamber of Commerce and Industry** and **Tel Aviv Chamber of Commerce** <u>signed</u> a strategic partnership agreement that aims to establish a framework for bilateral economic cooperation and mutually beneficial partnerships (September 2020).
- Through its Dubai Diamond Exchange, DMCC <u>signed</u> an agreement with the Israel Diamond Exchange to foster collaboration by sharing knowledge, partnering on exhibitions and promoting bilateral trade opportunities (September 2020).
- Abu Dhabi Investment Office (ADIO) <u>signed</u> a cooperation agreement with the Israel Export Institute to collaborate on trade and investments (October 2020).
- The **UAE** and **Israel** <u>reached</u> a bilateral agreement to protect investors from arbitrary changes in regulations and political situations (October 2020).

- **KIKLABB** and **NY Koen Group** <u>announced</u> a partnership agreement which aims to facilitate cultural understanding, foreign investment and business development between the business communities of the UAE and Israel (November 2020).
- Abu Dhabi Ports and the Manufacturers Association of Israel <u>signed</u> an agreement to enhance trade, investment and technology cooperation between the UAE and Israel (December 2020).
- Etihad Credit Insurance and the Israel Foreign Trade Risks Insurance Corporation signed an agreement to develop economic relations between the two countries (December 2020).
- Abu Dhabi Securities Exchange and the Tel Aviv Stock Exchange <u>signed</u> a MOU to facilitate channels of communication and develop capital markets in the UAE and Israel (December 2020).
- DP World's Smart Solution Logistics FZE <u>signed</u> an agreement with Israel-based Allalouf Logistics to explore growth opportunities for the logistics and general freight forwarding business in the UAE and Israel (January 2021).
- The Dubai Investment Development Agency (Dubai FDI), an agency of Dubai Economy, signed an agreement with the Manufacturers' Association of Israel to explore collaboration in promoting cross-border business and investment opportunities (March 2021).
- Israel's **Money Laundering and Terror Financing Prohibition Authority** at the Ministry of Justice and the UAE's **Financial Intelligence Unit** <u>signed</u> an MOU aimed at strengthening cooperation to address money laundering (March 2021).
- The **UAE** and **Israel** <u>signed</u> a tax treaty to avoid double taxation that will help promote bilateral trade and investment in years to come (May 2021).
- HH Sheikh Abdullah bin Zayed and Israeli Foreign Minister Yair Lapid <u>signed</u> an agreement on economic and trade cooperation to foster economic ties and related opportunities (June 2021).
- The **UAE** and **Israel** <u>signed</u> an agreement to facilitate cooperation in energy sector priorities, such as clean energy and energy storage (November 2021).
- The **UAE** and **Israel** <u>signed</u> an MOU on cooperation in maritime transport (April 2022).
- The **UAE** and **Israel** <u>signed</u> a free trade agreement, the first of its kind for the region, seeking to expand bilateral trade to \$10 billion by 2027 (May 2022).
- 35 business agreements were <u>signed</u> in 2022 between the **UAE** and **Israel** in areas as diverse as cooperation in the fields of health and the environment to collaboration in agriculture, security, and water (January 2023).
- The **UAE** and **Israel** <u>signed</u> a Comprehensive Economic Partnership Agreement (CEPA), reducing or removing tariffs on about 96% of goods traded between the nations (March 2023).

• **UAE** and **Israeli** firms <u>signed</u> an MOU to tackle global agriculture challenges including food security and desertification (August 2023).

Technology

- The Mohamed Bin Zayed University of Artificial Intelligence and Israel's Weizmann Institute of Science are working together to advance the development and use of AI through academic exchanges, conferences and the establishment of a virtual institute for AI (September 2020).
- Abu Dhabi Global Market <u>announced</u> it would sign an MOU with Israel Securities Authority and Bank Hapoalim to support the fintech sector through projects to facilitate international trade, business and financial services activities between the UAE and Israel (November 2020).
- **DIFC FinTech Hive** <u>signed</u> an agreement with Israel's **FinTech-Aviv** to strengthen the role of Dubai International Financial Centre as a global fintech hub (November 2020).
- The **UAE-Israel Tech Zone** <u>launched</u> to connect over investors, technology leaders, government officials and developers and promote business cooperation in the tech sector (December 2020).
- EDGE and Israel Aerospace Industries <u>signed</u> an MOU to develop an advanced C-UAS (Counter- Unmanned Aircraft System) tailored to the UAE market (March 2021).
- **G42** and **Rafael Advanced Defense Systems** <u>formed</u> a joint venture to commercialize AI and big data technologies (April 2021).
- The **UAE** <u>approved</u> a multi-million dollar joint fund with **Israel** to support private sector technology research and development (January 2022).
- HH Sheikh Abdullah bin Zayed Al Nahyan <u>met</u> with the Minister of Finance of Israel, Avigdor Lieberman to discuss opportunities in trade and finance. (September 2022).
- A joint **UAE-Israel** R&D <u>fund</u> to support tech projects involving Emirati and Israeli companies was announced (December 2022).
- The **UAE** and **Israel** <u>established</u> the **Crystal Ball Initiative**, a global platform to fight ransomware cyberattacks (June 2023).
- The UAE's **G42** <u>teamed</u> up with **Viola** in Israel to address the worldwide tech employee shortage (June 2023).

Energy & Environment

• **Masdar** and Israel's **EDF Renewables** <u>announced</u> an agreement to explore renewable energy opportunities in Israel and support the country's clean energy objectives (January 2021).

- Israel's Delek Drilling announced the signing of a non-binding MOU with Mubadala Petroleum for the sale of Delek Drilling's 22% non-operated stake in the Tamar gas field (April 2021).
- An agreement was <u>signed</u> to launch a joint Israeli-Emirati water research program as part of a collaboration between the Israeli Watergen company and Baynunah, a sister company of Al Dahra Group, an Emirati agriculture group that specializes in food security (June 2021).
- **HE Mariam Almheiri** <u>signed</u> an MOU with Israeli Agriculture Minister **Oded Forer** that aims to enhance cooperation in the areas of food production, food supply chains, and research and innovation (July 2021).
- **HE Mariam Almheiri** <u>signed</u> a second MOU with Israeli Minister of Environmental Protection **Tamar Zandberg** aimed at joint research efforts for the mitigation of climate change and ensuring biodiversity and ecosystem conservation (July 2021).
- UAE, Jordan, and Israel <u>sign</u> MoU to advance Project Prosperity, at COP27. Previously at Expo 2020 Dubai, the **UAE**, Jordan, and Israel first <u>signed</u> an initial Declaration of Intent to explore the feasibility of the project.
- The **UAE**, **Israel** and **Jordan** <u>signed</u> a declaration of intent to build renewable electricity and water desalination capacity to address the threat posed by climate change on energy and water security in the MENA region (November 2021).
- The Ministry of Climate Change and Environment <u>signed</u> an MOU with Israel's Ministry of Agriculture and Rural Development to promote partnership in agricultural R&D (March 2022).
- The **UAE**, **Jordan**, and **Israel** <u>signed</u> a MOU to speed progress on a deal to exchange solar energy for desalinated water (November 2022).

Health

- The UAE and Israeli health ministries <u>agreed</u> on immediate cooperation in the healthcare sector. The ministers pledged to appoint a representative responsible in part for coordinating relations between both countries, particularly in the response to COVID-19 (August 2020).
- Abu Dhabi's G42 Healthcare <u>signed</u> an agreement with Israel's NanoScent to develop, distribute and manufacture a test that detects COVID-19 from exhaled air (August 2020).
- Pluristem Therapeutics Inc. and the Abu Dhabi Stem Cells Center <u>signed</u> an MOU to collaborate on activities related to advancing the treatment and research of cell therapies (August 2020).

- Emirati company **APEX National Investment** <u>signed</u> a strategic commercial agreement with Israel's **Tera Group** to cooperate on COVID-19 research and development, with a focus on advancing testing and vaccine technology (August 2020).
- Israel's Sheba Medical Center and APEX National Investment <u>signed</u> a preliminary agreement to jointly promote healthcare technologies in the UAE and the Gulf region (September 2020).
- **SURE Universal Ltd**, a developer of IoT (Internet of Things) software for home healthcare, <u>partnered</u> with **HBK Department of Projects** in the UAE to launch a white-label smart IoT healthcare solution for both the UAE and Middle East regional markets (September 2020).
- The Galilee Medical Center and Azrieli Faculty of Medicine at Bar-Ilan University in the Galilee <u>signed</u> an agreement with the dental clinic at the Gulf Medical University to collaborate in the fields of dentistry and oral and maxillofacial surgery (December 2020).
- Israeli MediWound, a maker of a pineapple-based gel to treat burn victims, <u>signed</u> a marketing and distribution agreement UAE conglomerate Ghassan Aboud Group for the commercialization of its NexoBrid drug in the UAE for the treatment of severe burns (December 2020).
- **Bar-Ilan University** <u>signed</u> an agreement with the UAE's **Gulf Medical University** to promote medical research and improve public health throughout the Middle East (January 2021).
- **Zulekha Hospital** in the UAE and Israel-based **Health Plus** <u>signed</u> a mutual agreement to cooperate in the field of medical tourism (February 2021).
- The Emirates Health Services Establishment (EHSE) <u>signed</u> an agreement with the Israeli Ministry of Health aimed at enhancing quality of healthcare in the two countries (April 2021).
- Dubai-based **SJM Group** and **INMED**, an Israeli medtech startup, will <u>partner</u> on creating a digital health platform for remote patient management in Dubai (July 2021).
- The **Department of Health-Abu Dhabi** <u>signed</u> an MOU with **Clalit Health Services**, the largest HMO in Israel and second largest globally, on healthcare cooperation (July 2021).
- The **Department of Health-Abu Dhabi** <u>signed</u> an MOU with **Sheba Medical Center**, creating a framework for cooperation in developing and improving healthcare services (July 2021).
- Israel's Illumigyn <u>signed</u> an MOU with UAE-based **Digital Health Innovation (DHI) 2048** to deploy 2,500 gynescope systems to the region by the year 2025 (August 2021).
- The **UAE** and **Israel** <u>signed</u> an MOU to collaborate on COVID-19 vaccine monitoring and verification (October 2021).

- Israel's **Beth Israel Deaconess Medical Center** <u>signed</u> an MOU with the Government of **Abu Dhabi** to establish an emergency medicine center in the Emirate (February 2022).
- Abu Dhabi's Department of Health, the United Arab Emirates' healthcare regulator and Israel's Kahn Sagol Maccabi Research and Innovation Center <u>signed</u> a MOU to increase cooperation in technological innovation and healthcare research in Abu Dhabi (February 2023).
- The UAE and Israel signed a health agreement between the UAE's largest health player, PureHealth, and Israeli's largest hospital, Sheba Medical Center, to closely collaborate on joint clinical research projects, promote the use of advanced technology in healthcare, expand genetic research initiatives and boost health tourism in both countries (June 2023).

Tourism & Aviation

- Israel was <u>invited</u> to participate in Expo 2020 Dubai in April 2019. The Israel Pavilion was featured at Expo from October 2021 to March 2022.
- The UAE's **General Civil Aviation Authority** <u>signed</u> an air transport services agreement with the **Civil Aviation Authority of Israel** to strengthen bilateral air transport relations and expand air links between the two countries (October 2020).
- Etihad Airways and El Al Israel Airlines <u>signed</u> an MOU to introduce codeshare services and frequent flyer programs with the aim of encouraging tourism to Abu Dhabi and Tel Aviv (November 2020).
- The **UAE** and **Israel** <u>ratified</u> a bilateral agreement that will exempt tourists from both countries from visa requirements when visiting the other country (November 2020).
- Abu Dhabi National Exhibitions Company (ADNEC) and Expo Tel Aviv <u>signed</u> an MOU to collaborate in the regional business tourism sector (February 2021).
- Israel Aerospace Industries <u>signed</u> an agreement with Etihad Engineering to establish a facility in Abu Dhabi that will convert Boeing passenger planes into cargo aircraft (August 2021).
- The **UAE Space Agency** <u>signed</u> an MOU with the **Israel Space Agency** to enhance cooperation in scientific research and space exploration (October 2021).
- The **UAE** and **Israel** <u>signed</u> an MOU to strengthen their tourism and economic cooperation and reinforce their bilateral ties (February 2022).
- **Emirates Airline** <u>announced</u> plans for a second daily flight between Dubai and Tel Aviv starting in October 2022 (July 2022).
- **UAE** and **Israel** agree to <u>increase</u> passenger flights for the summer, bringing the weekly number of flights to Dubai to 49, second only to flights to Istanbul (March 2023).

• Israel is Dubai's fastest growing source of <u>tourism</u> year-over-year, with seven weekly flights and over 74,000 Israelis flying to the UAE last month alone (April 2023).

- **UAE** and **Israeli** health ministry officials <u>announced</u> that both countries would create a student exchange program once conditions allowed amid the COVID-19 pandemic (August 2020).
- The Abu Dhabi Film Commission, Israel Film Fund and Jerusalem Sam Spiegel Film & Television School <u>reached</u> an agreement to cooperate in the fields of film and television (September 2020).
- The **UAE Pro League** signed an MOU with the **Israeli Professional Football League** to jointly advance football-related activities (October 2020).
- The **Ahmed bin Zayed Foundation** and **Yitzhak Rabin Center** <u>signed</u> an MOU which aims to provide humanitarian aid to all segments of society, regardless of their religion (October 2020).
