








Missouri ranked 32nd among U.S. states and territories with \$0.3B in goods exported to the UAE between 2016 and 2019

Exhibit I.1 | U.S. State Rankings of Exports to the UAE (\$ in Billions)










Total value of 2019 goods exported is highest in last four years

Exhibit I.2 | Missouri Export Values and Percent of Total by Year










In 2019, Motor Vehicle Body, Trailer and Parts Manufacturing and Scrap, Second-Hand and Special Classification were the largest exporting sectors

Exhibit I.3 | Missouri's Exporting Sectors in 2019





Exhibit I.4 | Missouri's Exporting Sector Movements From 2018 to 2019
















